Membership fees are set to cover operating expenses which include coaching, dock fees, insurance, gas and maintenance on the launch, etc. In order to purchase new equipment to meet our evolving needs, we must fundraise. The Board has set a very ambitious fundraising goal of \$10,000 this year.

Our easiest and most lucrative fundraiser is selling Weis and Giant gift cards. Members and friends purchase the gift cards at face value and the club gets 5% of the proceeds. If 42 members all purchase just \$200-worth of cards each month, we would net \$5040, or half of our annual fundraising goal. Double that commitment and we would exceed our annual goal.

All members are asked to commit to purchasing gift cards each month. A regular distribution system will ensure that people safely receive grocery cards each month.
